FACTS	WHAT DOES CALIFORNIA COAST CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:
	 Social Security number and account transactions Account balances and payment history Credit history and wire transfer instructions
	When you are <i>no longer</i> our member, we continue to share your information as described in this notice.
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons California Coast Credit Union chooses to share; and whether you can limit this sharing.

Who is providing this notice?	California Coast Credit Union	
How does California Coast Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.	
How does California Coast Credit Union collect my personal information?	 We collect your personal information, for example, when you: Open an account or make deposits or withdrawals from your account Apply for a loan or pay us by check Show your driver's license 	
	We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.	
Why can't I limit all sharing?	 Federal law gives you the right to limit only: Sharing for affiliates' everyday business purposes – information about your creditworthiness Affiliates from using your information to market to you Sharing for non-affiliates to market to you 	
	State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.	
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on the account.	

Definitions		
Affiliates	 Companies related by common ownership or control. They can be financial and nonfinancial companies. California Coast Credit Union does not share with our affiliates. 	
Non-affiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies: California Coast Credit Union does not share with non-affiliates so they can market to you. 	
Joint marketing	 A formal agreement between non-affiliated financial companies that together market financial products or services to you. Our joint marketing partners include providers of financial products and services. 	

Other important information	
For California members	California law gives you the right to opt out of certain sharing. Please see the form entitled "Important Privacy Choice For Consumers" included with this notice.



Important Privacy Choice for Consumers

You have the right to control whether we share some of your personal information. Please read the following information carefully before you make your choicebelow.

Your Rights

You have the following rights to restrict the sharing of personal and financial information with outside companies that we do business with. Nothing in this form prohibits the sharing of information necessary for us to follow the law, as permitted by law, or to give you the best service on your accounts with us. This includes sending you information about some other products or services.

Your Choice

Restrict Information Sharing With Other Companies We Do Business With To Provide Financial Products And Services: Unless you say "No," we may share personal and financial information about you with outside companies we contract with to provide financial products and services to you.

NO, please do not share personal and financial information with outside companies you contract with to provide financial products and services.
